The search is on for creative Dickens vendors to populate the streets of Wellsboro during the 36th Annual Dickens of a Christmas celebration, Saturday, December 7th, 2019, 9:00 a.m. to 4:00 p.m. Please review the following guidelines prior to applying.

- This is a juried arts & crafts show.
- All arts and craft items <u>MUST BE HANDCRAFTED</u> (no kits or imports please), and must be appropriate to the holiday season.
- Victorian garb and seasonal decorations are a requirement for all booths. There will be a costume workshop for interested "Dickens of a Christmas" vendors/participants, on Wednesday, November 6th in the lobby of the Penn Wells Hotel at 7:00 p.m.
- Participants are responsible for their own display equipment, tables, etc.
- No Canopies please! (In the event of inclement weather, we recommend that you bring your canopy and check with your block captain before erecting.)
- Display cannot exceed more than 3 feet high from the table top.
- Electricity is not available; please do not request electric from business owners.
- An application-processing fee of \$15 must accompany your application, checks should be payable to the Wellsboro Chamber of Commerce. This fee is nonrefundable regardless of your acceptance status to the show. The processing fee is waived for nonprofit organizations.
- Booth fees will not be refunded, for any reason, after October 1st, 2019.

PREPAID, NON-REFUNDABLE, booth rental fees are as follows:

5 ft. x 6 ft. - \$100

10 ft. x 6 ft. - \$185

Get your application in early. THE DEADLINE FOR JURY IS May 10, 2019.

Following completion of the jury process, vendors accepted will receive a map showing your reserved space and further information. We will mail out acceptance near August 1st, but please allow time for mail to be delivered.

NOTE: Do not assume admission: All applications will be juried. We reserve the right to reject items that are not appropriate.
