

Dear Friend:

We are now accepting applications for the 2026 Pennsylvania State Laurel Festival's annual Juried Arts & Crafts Fair. This letter contains full details of the show as well as information for the application process.

### **General Info**

Dates for this year's show are Friday, June 19 and Saturday, June 20. Show hours are Friday 10 AM - 8 PM and Saturday 9 AM - 6 PM.

This is an OUTDOOR show; held RAIN OR SHINE, please come prepared.

Please note that parking for vendors is approximately 1,000 yards from the set-up location. All vendors will need to park at that location after unloading and for the duration of the show. Any vendor parking in non-designated vendor area will be towed at the expense of the vehicle owner, NO EXCEPTIONS. We do not have dedicated handicapped parking for vendors. Please plan accordingly.

For insurance reasons, vendors may **NOT** have pets in their booths.

### **Requirements for Art Work**

All **products must be handcrafted**, not from kits. Any vendor displaying items purchased from wholesale suppliers will be asked to remove them. All vendors will be juried during the show by one of the original jury committee. **The Festival Committee reserves the right to pass judgment in regards to the above rule of eligibility when reviewing applications, but also during the show.**

ALL applications for vendor space must be accompanied by **four (4) current, crisp, clear photos showing your product, one (1) showing your raw materials, one (1) showing you making your product, and one (1) current photo of your booth setup, in order to be considered. For accepted vendors, photos will be retained on file until the day of the show.**

### **Jury Process**

**ALL APPLICANTS MUST SUBMIT TO THE JURY PROCESS. - PRIOR YEAR ACCEPTANCE DOES NOT GUARANTEE ACCEPTANCE IN CURRENT YEAR. Do not assume admission without jury approval. Deadline for submission of applications is January 15, 2026.** All applicants will be advised of acceptance by March 16, 2026. A map showing booth location will be provided prior to the show. When completing the application, it is important that you list **all** types of items you sell. **Vendors may be asked to remove non-juried merchandise.** The decision of the jury is final.

### **Payment**

Booth fee is per space for two days, includes electricity, and is non-refundable  
(over please)

upon acceptance. There is also a **non-refundable \$15 application fee**. Please include payment in the form of **two (2) checks**, both made payable to PA State Laurel Festival.

*Please post-date your booth fee check after January 1, 2026.* If you are declined entry by the jury, your booth fee check will be returned promptly.

### **Space Locations**

Booth sizes are: 10'x10' (\$200); and 20'x10' (\$400). Since the aisles are narrow, we ask that you please keep your merchandise within your booth space. **Do not erect additions on the rear or sides of your space.**

When completing the application, you must list the size, width, and height of your display, **including whether or not you have a canopy**. We encourage all vendors to demonstrate their art or craft during the show. If you will be demonstrating, please let us know so that we can provide you with additional publicity.

### **Important Dates**

**Application Deadline:** January 15, 2026

**Notification of Accept/Reject:** Approximately March 16, 2026

**Set-up:** Thursday, June 18, **2 PM- 7 PM** and Friday June 19, **7 AM -10 AM**.

**Show Hours:** Friday, June 19, **10 AM - 8 PM** & Saturday, June 20, **9 AM- 7 PM**  
**Vendors tearing down their booth before the end of the show, leaving the show early or arriving late, without prior arrangement with the committee, will not be invited to return.**

The Wellsboro Police Department has requested that **NO Vendor setup prior to 2PM on Thursday, June 18.**

### **Vendor Checklist**

- ❑ Self-addressed stamped envelope with sufficient postage. Photos will not be returned without sufficient postage.
- ❑ One check in the full amount of the booth space **post-dated after** January 1, 2026
- ❑ One check for the application fee of \$15
- ❑ Completed application - **including PA tax #** (Call PA Dept. of Revenue for application, 717-787-1064)
- ❑ 4 current, crisp, clear photos showing your finished, handcrafted product, 1 photo of your raw materials, 1 current photo of you making your product, and 1 photo of your booth setup.

**ANY REQUEST THAT DOES NOT INCLUDE ALL OF THESE ITEMS WILL BE CONSIDERED INCOMPLETE AND WILL BE RETURNED TO THE APPLICANT**
